NOT COVERED: Supply Water Line and Water Cutoffs to Unit. All items not affecting operation.

15. DISHWASHER: (Built-In Only)

COVERED: Pump and Motor Assemblies, Spray Arms, Timer, Electrical Controls, Heating Elements, Door Gaskets, Seals and Water Leaks.

NOT COVERED: Baskets, Racks, Rollers, Cabinet, Trim Replacement of Water Supply lines and Valves.

16. GARBAGE DISPOSAL:

COVERED: Parts and Labor to repair, Electrical, Plumbing Connection, Gaskets, plus other internal components.

17. TRASH COMPACTOR:

COVERED: Switches, Motor, Wiring and operational parts.

COVERED: Fan Blades, Motors only.

NOT COVERED: Switches, Housing, Venting-Ducting, Dampers, Trim, Grills, Knobs, Attic Fans, Thermostats-Electronic Controls. Hood portion itself.

23. CEILING FANS: (Two Each)

COVERED: Parts and Labor to repair.

NOT COVERED: Housings, Broken Blades.

24. GARAGE DOOR OPENER:

COVERED: Motor, Switches, Receiver Unit, Wiring, Push Arm and Carriage.

NOT COVERED: Remote Transmitters, Springs, Tracks, Hinges, Doors, Hardware, Adjustments, and light bulbs.

28. PLUMBING SYSTEMS: (Basic Only)

COVERED: Stoppage in Sinks, Tubs, Toilets. Repair Toilet Tank Bowls-Flapper Assemblies, Wax rings Seals, Ballcocks, Faucet Washers, Seats in Single Lever Faucets. NOT COVERED: Jets, Solar Equipment, Pool Sweeps, Pool Sweep Motor, Cleaning Equipment, Any Structural Defects, Plaster, Tile, Pool Defects, Strainer Material, Filter Cartridges, Timers, Lights, Concrete Encased Above- Underground Electrical, Water, Gas, or Drain, Fill, Vent, lines. Automatic chlorinators.

- C. Free Emergency Service on your air-conditioning Unit if the unit is not providing cooling or heating, or water heater leaking, refrigerator not cooling.* Max. Limits do apply to covered items. A/C is \$1500.00, Plumbing is \$1000.00, Others are \$400.00.
